

2010 Investment Schedule

Membership in the St. Joseph Area Chamber of Commerce is determined by the schedules offered below. Investments are based on two factors: number of full-time equivalent (FTE) employees and type of firm or organization.

If your business does not fall into one of the Special Investment categories, you need to determine your FTE employee level. Only count employees that work in St. Joseph and do not count seasonal workers. Two part-time employees count as one full-time. If the part-time employment level does not divide evenly, drop one employee. Companies located outside a 20-mile radius of St. Joseph pay the base amount of \$313.

Once you have determined your employment level, locate that level in the General Membership box. The amount at this location is your annual investment in the Chamber. This entire amount plus a processing fee of \$35 is to be paid upon application. Please return completed application form with payment.
